The Acer Predator Gaming and Steam Voucher Promotion - TERMS & CONDITIONS

Clause 1. General provisions

- 1. This Promotion is being promoted by Acer Africa (Pty) Ltd (the "Organiser"). Each person who participates the promotion agrees to abide by these terms and conditions.
- These terms and conditions (hereinafter the Terms and Conditions) specify the rules for participating in the Promotion organised by the Organiser and contain conditions for participation that the Participant accepts by participating in the Promotion.

Clause 2. Rules of Promotion

Clause 5. Personal data

- The Participants shall be able to participate in the Promotion only if they give consent to the
 processing of their personal data for the purposes connected with the conducting of the
